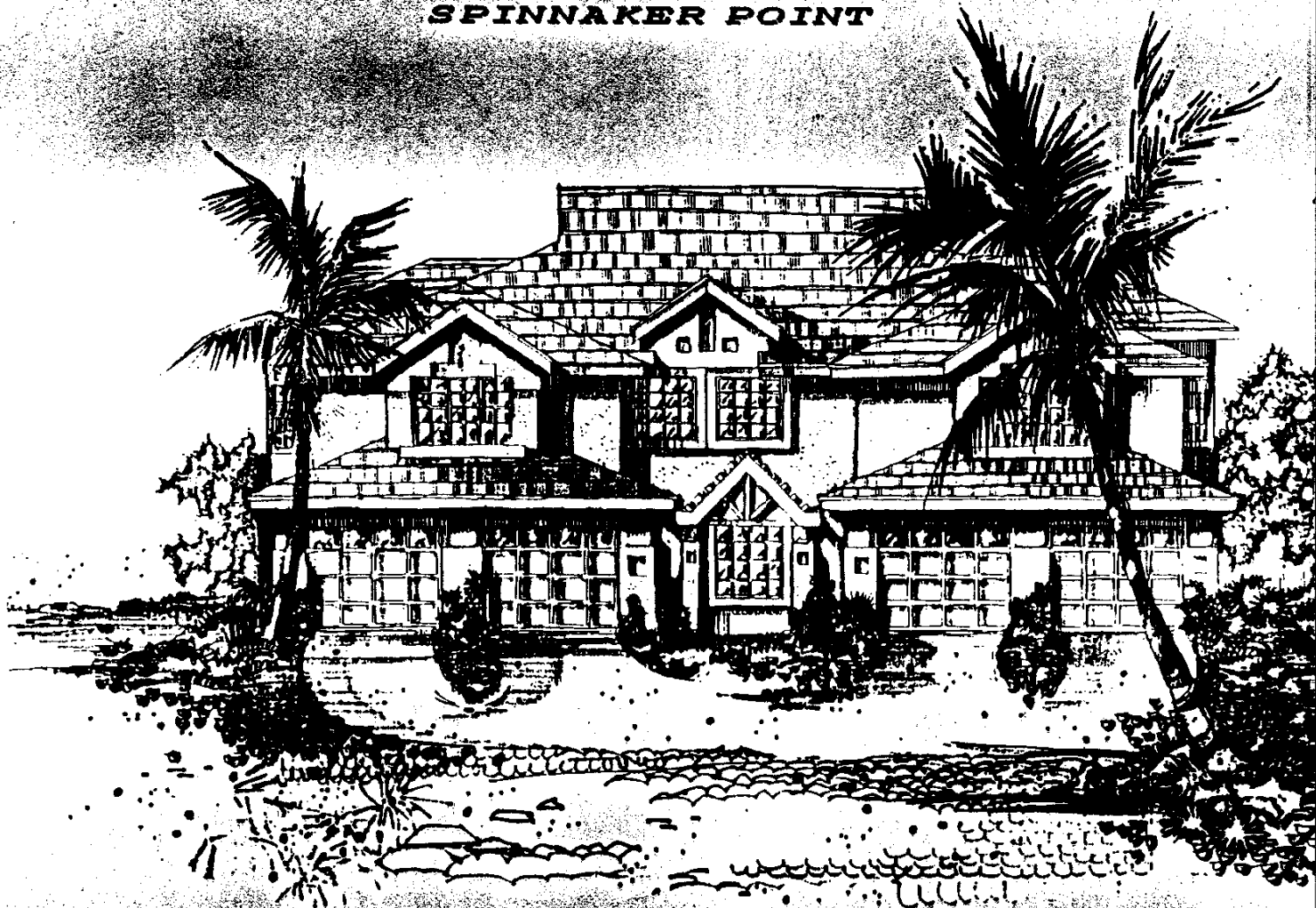


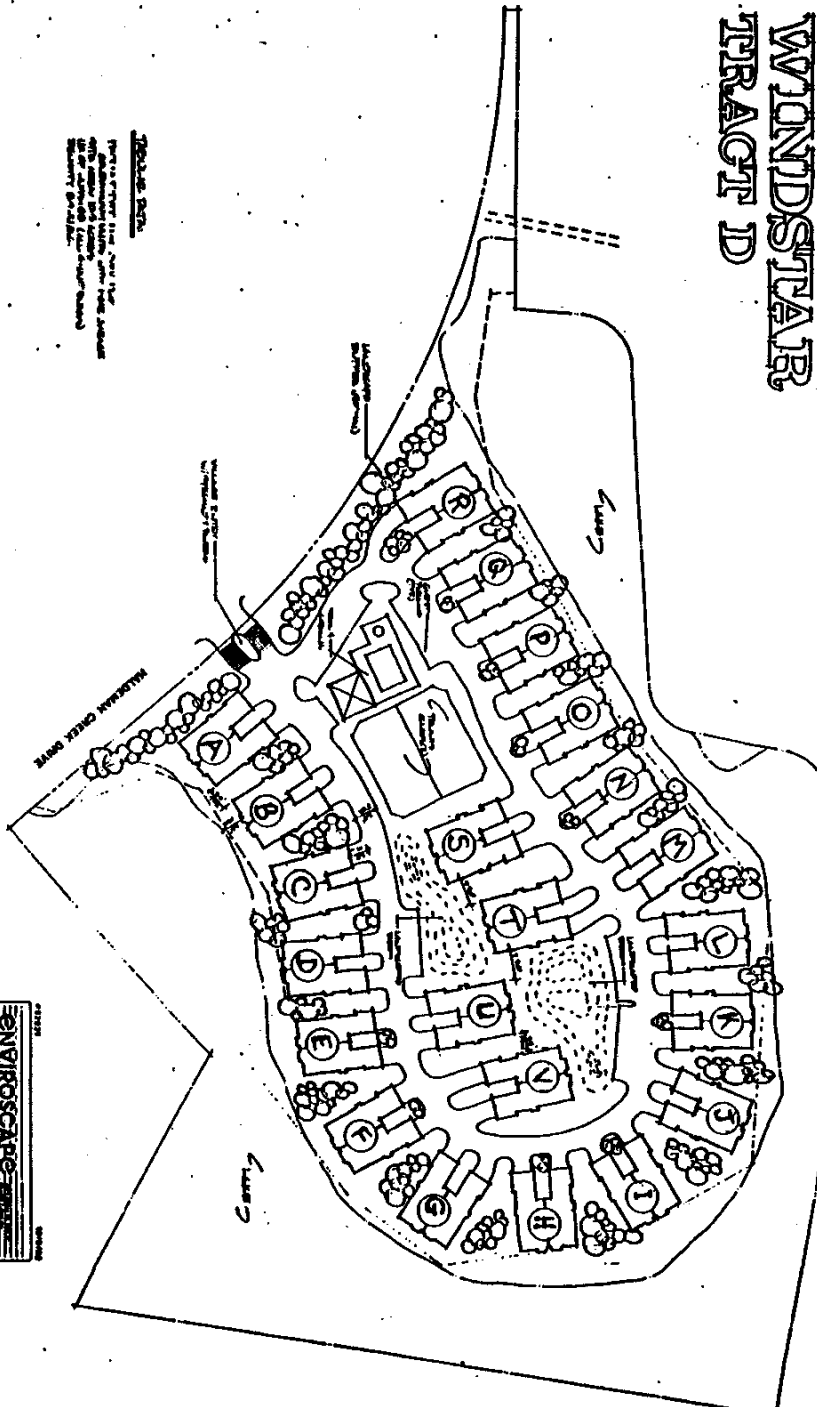

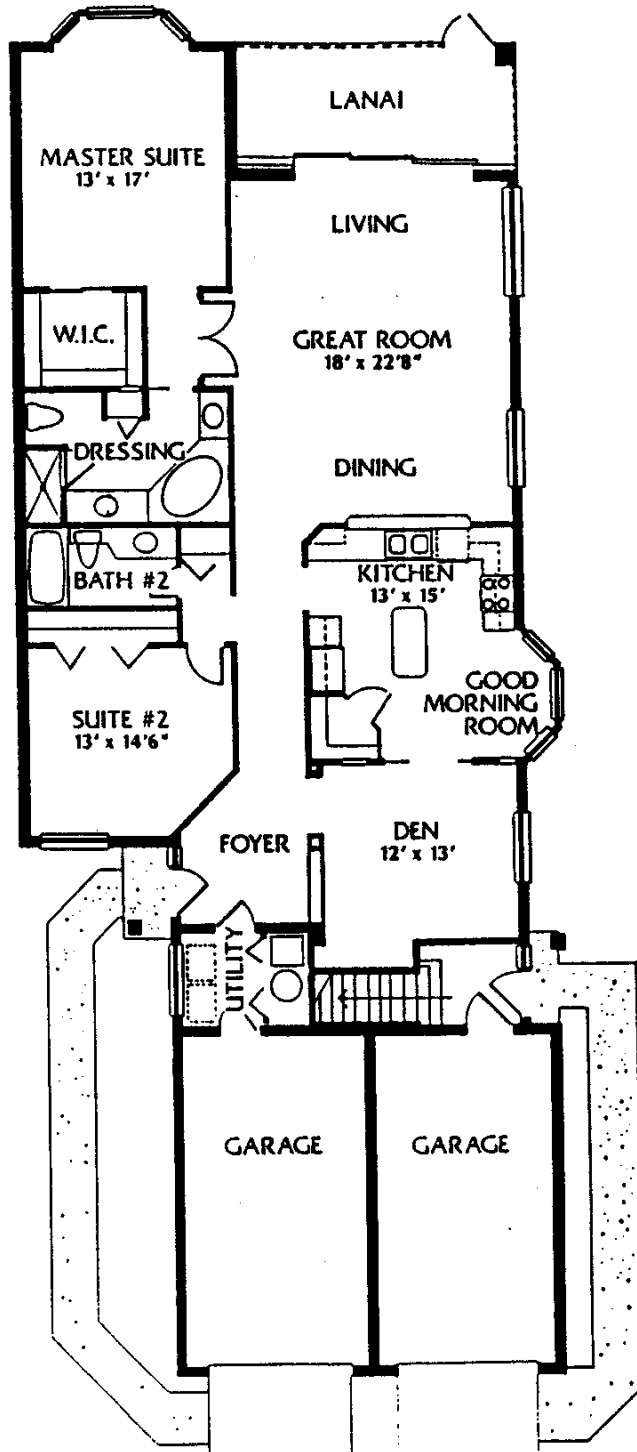

CONCEPTUAL SITE PLAN A

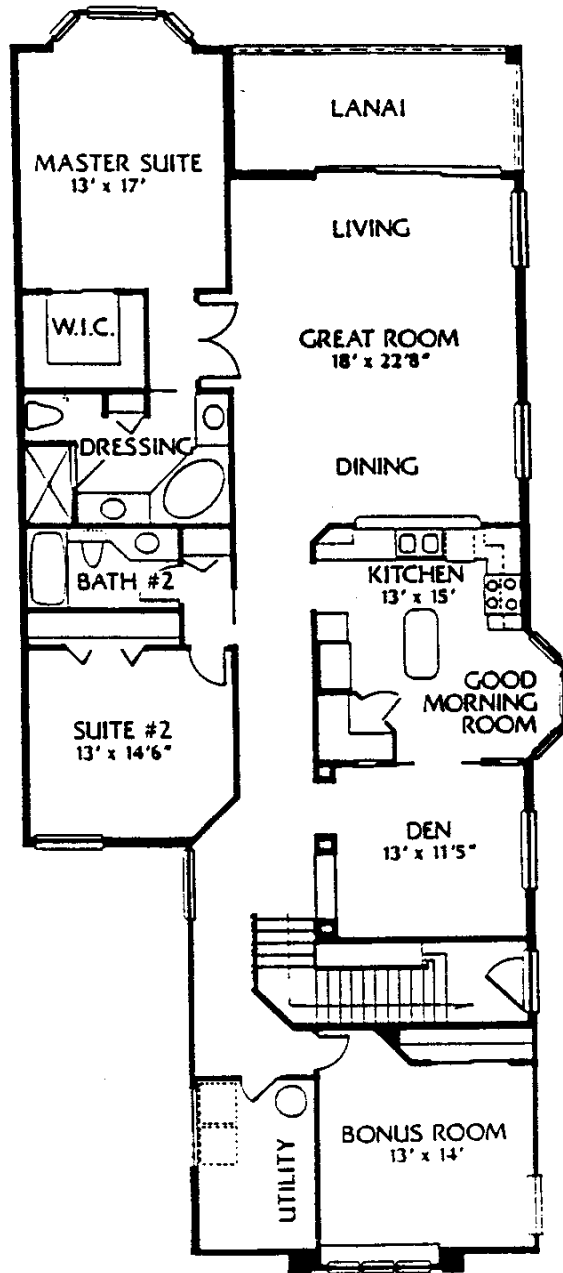
