REALTOR® Code of Ethics Training Information & Schedule

4th Quadrennial (January 2013-December 2016)

FOR REALTOR® MEMBERS ONLY

Effective January 1, 2001 and for successive four year periods thereafter, each REALTOR® is required to complete the National Association of REALTORS® mandatory Code of Ethics Training once during each quadrennial period.

Mandatory Code of Ethics training requirement for new and continuing REALTOR® members was established by the National Association's Board of Directors at the 1999 Annual Convention to heighten member awareness of the key tenets of the Code of Ethics; to create an awareness of and appreciation for the role the Code can and should play in their professional lives; to enhance professionalism and competency; and to encourage REALTORS® to view their Code of Ethics as a living, viable guide in their daily dealings with clients, customers and the public. FREQUENTLY ASKED QUESTIONS & ANSWERS

- 1. Who mandates the REALTOR® Code of Ethics ("COE") training? The National Association of REALTORS® ("NAR").
- 2. Does my real estate license renewal course satisfy NAR's COE training requirement?
 No.
- 3. Are there other methods available to complete NAR's COE training? Yes, through other Boards/Associations or through other methods (including, but not limited to, home study, correspondence courses, or Internet-based instruction). Any training offered pursuant to this requirement must meet the learning objectives and minimum criteria established by NAR from time to time. If you have taken such a course and are not sure if it meets NAR's requirements, Please contact Corie Chase at 239-597-1666 X224 or Corie@NABOR.com. Important: If you choose this option, please see question and answer #5 below.
- 4. Can I complete the COE training on line? Yes. NAR's website (www.REALTOR.org) offers online COE training. For NAR online course instructions please visit (https://www.youtube.com/watch?v=NYAOPTtqOCE.) For additional information, please contact NAR directly at 1-800-874-6500.
- 5. If I complete my COE training at a venue outside of my primary Board/Association will my Board automatically be notified? No. It is the responsibility of each individual REALTOR® to provide a Certificate of Completion to their primary Board/Association. The only exception to this rule is if you complete your COE training online at www.realtor.org.
- 6. As the Broker of my firm, can I obtain a list of my agents who have not complied with the current COE training? Yes. Please contact Corie Chase at 239-597-1666 X224 or Corie@NABOR.com.
- 7. What happens if I don't comply with NAR's COE training? Failure to meet the requirement for the current cycle and subsequent cycles will result in suspension of membership for the first two months (January and February) of the year following the end of any cycle or until the requirement is met, whichever occurs sooner. On March 1 of that year, the membership of a member who is still suspended as of that date will be automatically terminated.
